

## REMINDER OF CRITERIA APPLIED BY THE COMMISSION OF SELECTION

#### 1. GENERAL CRITERIA APPLIED BY THE SELECTION BOARD

- Eligibility and completeness of applications;
- The MOBLILEX scholarship is not cumulative with other scholarships programs: Erasmus+, MIC, AMI, MERMOZ (study/internship or research), Doctoral College and graduate programs. *Any student eligible for one of these programs, is not eligible for the MOBLILEX scholarship*.
- Possibility to benefit from the Moblilex grant once per cycle of studies (BUT/Master/Engineer; Doctorate). This rule also applies to the Young Researcher and Post-Doc.
- Reasoned opinion and classification of faculties, laboratories and doctoral schools (any file not classified and not containing a reasoned opinion will not be examined and will be immediately rejected)
- For <u>incoming mobilities</u>: students and doctoral candidates must be in a mobility situation (students and doctoral candidates already present in Lille are not eligible).
- The program Moblilex does not finance incoming mobility for young researchers and post-docs.
- Priority given to mobilities in the framework of existing and structuring cooperations (bilateral agreement, IRL (International Research Laboratory) research cooperation agreement, double degree...)

University of Bonn (Germany), KU Leuven (Belgium), State University of Sao Paulo (UNESP – Brazil), Mc Gill University (Canada), University of Chile (Chile), Arizona State University (USA), Wayne State University (USA), Kwame Nkrumah University of Science and Technology (KNUST - Ghana), Nagoya University (Japan), University College of London (UCL – UK), Alliance "University System of Taipei" (Taiwan): Medical University of Taipei (TMU), National Taipei University, National Taiwan Ocean University, National Taipei University of Technology - 3i Network (KU Leuven/Kent/Gand), Inclus'U Network.

# 2. SPECIFIC CRITERIA APPLIED TO THE MASTER'S/ENGINEER LEVEL

#### **INCOMING MOBILITY:**

- Priority given to students considering a thesis project at the University of Lille (please add a description of the project on one page, specifying the research director and the research team identified)

#### 3. Specific criteria applied to mobility at the doctoral level mobility

The doctoral school (ED) reasoned opinion that justifies file classification must take into account in particular the following:

- The progress of the thesis.
- The relevance of the Mobility at this stage in the progress of the thesis.
- The existence of structured cooperation for work and/or for the research unit and/or for the university where the mobility is envisaged. Ex. formal or informal partnerships, current or future, actual or potential (joint partnership; IRN, IRP; other research programs)
- Whether or not the doctoral student receives funding. (co-financing)
- Sincerity and reasonability of the budget

#### **INCOMING MOBILITY:**

ATTENTION: MOBLILEX is a mobility scholarship that cannot be used as a financing of the thesis but which allows to finance the necessary mobility during the thesis.

- Final MOBLILEX ranking carried out and reported by the **Doctoral Schools**.
- For incoming doctoral mobilities, the MOBLILEX scholarship would be awarded primarily to doctoral students in joint supervision" cotutelle". (Agreement finalized or in preparation)
- Taking into account the year of enrollment in thesis (only PhD students enrolled in 1st, 2nd and 3rd year are funded, or on derogation and reasoned opinion for 4th year.

### **OUTGOING MOBILITY:**

ATTENTION: mobility of less than 3 months is not eligible and may be the subject of an application to the Doctoral College.

- Final MOBLILEX ranking carried out and reported by the **Doctoral Schools**
- Taking into account the year of enrollment in thesis (only PhD students enrolled in 1st, 2nd and 3rd year are funded, or on derogation and reasoned opinion for 4th year )
- For the PhD level, those applications eligible for Mermoz Research but not selected following the study of their application by the Region have the opportunity to submit an exceptional application. Applications will be considered in a virtual Mobilex commission.

#### 4. SPECIFIC CRITERIA APPLIED TO OUTBOUND MOBILITY FOR YOUNG RESEARCHERS AND POST-DOCS

Are considered as young researchers, the researchers working at the University of Lille and having obtained their doctorate for less than 5 years.

The reasoned opinion justifying the classification of the file by **the main component of the Research Unit of** the young researcher and the POST-DOC must take into account in particular:

- The relevance of Mobility in relation to the young researcher's research
- The existence of structuring cooperation for work and/or for the research unit and/or for the university where the Mobility is envisaged. Ex. formal or informal partnerships, current or future, actual or potential (IRL; other research programmes)
- The possibility of co-financing (laboratory, etc.). Beware, if a mobility is co-financed, the MOBLILEX scholarship will not finance the same type of expenses.
- The sincerity and reasonability of the budget.

#### **OUTGOING MOBILITY:**

WARNING: mobilities of less than one continuous month are not eligible and participation in congresses or symposia is not eligible.

- Final MOBLILEX ranking performed and retrieved by the main component of the Research Unit

# 5. SPECIFIC CRITERIA APPLIED TO SHORT OUTBOUND MOBILITY FOR STUDENTS OF (INSPÉ/SANTÉ)

Short mobility is intended for the domain of (INSPÉ and/or Health sector) students wishing to undertake a short international mobility.

A reasoned opinion justifying the classification of the file by the main component shall take into account in particular:

- Internship agreement signed by the various parties involved/ study contract (learning agreement)
- The duration of mobility must not exceed 3 months.
- Priority to be given to compulsory mobilities.
