

REMINDER OF THE CRITERIA APPLIED BY THE COMMISSION OF SELECTION

1. GENERAL CRITERIA APPLIED BY THE SELECTION BOARD

- Eligibility and completeness of applications
- The MOBILLEX scholarship cannot be combined with other scholarships programs Erasmus+, AMI, MERMOZ (study/internship or research), Doctoral College and Graduate Programs scholarships. **Any student eligible for one of these programs, is not eligible for the MOBILLEX scholarship**
- Possibility to benefit from the Mobillex scholarship once per cycle of studies (**BUT-BUETI/Master/Engineer; PhD; Young researchers and post-doc**)
- Reasoned opinion and classification of components, laboratories and doctoral schools (any file not classified and without a reasoned opinion will not be examined and will be immediately rejected)
- For incoming mobility: students and doctoral students must be in a situation of mobility (students and doctoral students already present in Lille are not eligible). The program does not finance inbound mobility for young researchers.
- Priority given to mobility within the framework of existing and structuring cooperation (bilateral agreement, IRL (International Research Laboratory) research cooperation agreement, double-degree, etc.)

- **Priority mobility areas:**

Network 3i (KU Leuven/Kent/Ghent), European NeurotechEU Alliance, Inclu'U network and other partners identified as or likely to become priorities:

KU.Leuven - KUL (Belgium), Sao Paulo State University – International - UNESP (Brazil), Nagoya University (Japan), Arizona State University - (USA), Wayne State University - (USA), University of Bonn (Germany), Universidad de Chile (Chile), University College London - UCL (UK) , Kwame Nkrumah University of Science and Technology - KNUST (Ghana), Taipei Medical University - TMU (Taiwan)

2. SPECIFIC CRITERIA APPLIED TO THE MOBILITY AT (BUT-BUETI/MASTER/INGENIEUR) LEVEL

INCOMING MOBILITIES :

- Priority given to students considering a thesis project at the University of Lille (please add a description of the project in 1 page, specifying the research director and research team identified)

3. SPECIFIC CRITERIA APPLIED TO MOBILITY AT THE DOCTORAL LEVEL

The ED's reasoned opinion that justifies file classification must take into account in particular:

- The progress of the thesis
- The scientific quality of the on-site work program, its organization (schedule and steps) and the relevance of the mobility at this stage of the thesis
- The existence of structuring cooperation for the work and/or for the research unit and/or for the university where the displacement is envisaged. E.g. formal or informal partnerships, ongoing or future, real or potential (joint partner; IRN, IRP; other research programs)
- Whether or not the doctoral student receives funding
- Sincerity and reasonableness of budget

INCOMING MOBILITIES:

ATTENTION: MOBLILEX is a mobility scholarship that cannot be used as a thesis funding but that allows to finance the necessary mobilities during the thesis.

- Final MOBLILEX ranking carried out and reported by the Doctoral Schools
- For incoming doctoral mobilities, the MOBLILEX scholarship will be given as a priority to doctoral students in joint supervision (agreement finalized or under development)
- Taking into account the year of registration in thesis (are funded only doctoral students enrolled in 1st, 2nd and 3rd year, or on derogation and reasoned opinion for the 4th year)

OUTGOING MOBILITIES :

WARNING: mobility of less than 3 months is not eligible and may be the subject of an application to the Doctoral College.

- Final MOBLILEX ranking carried out and reported by the **Doctoral Schools**
- Taking into account the year of registration in thesis (are funded only doctoral students enrolled in 1st, 2nd and 3rd year, or on derogation and reasoned opinion for the 4th year)
- For the PhD level, applications eligible for Mermoz Research but not selected, following the study of their file by the Region, have the opportunity to submit an exceptional Moblilex application. Applications will be considered in a virtual commission.

4. SPECIFIC CRITERIA APPLIED TO OUTGOING MOBILITY FOR YOUNG RESEARCHERS AND POST-DOCS

Young researchers, are those who have completed their doctorate in less than 5 years and are employed at the University of Lille.

The reasoned opinion justifying the classification/ranking of the file by the main component of the Young Researcher, Research Unit must take into account in particular:

- The scientific quality of the on-site work program, its organization (schedule and stages) and the relevance of mobility in relation to the young researcher's research

- The existence of structuring cooperation for the work and/or for the research unit and/or for the university where the displacement is envisaged. E.g. formal or informal partnerships, ongoing or future, real or potential (IRL; other research programs)
- Possible co-financing (laboratory, etc.). Attention, if there is co-financing for the mobility, the MOBILEX scholarship cannot finance the same expenses.
- Sincerity and reasonableness of the budget.

OUTGOING MOBILITIES :

ATTENTION: Mobility for less than one continuous month, as well as participation in congresses or symposiums is not eligible.

- Final MOBILEX classification carried out and reported by the **principal component of the Research Unit.**
