1. GENERAL CRITERIA APPLIED BY THE SELECTION BOARD

- Eligibility and completeness of applications

- Respect for non-cumulation with other programmes of Scholarships: MERMOZ (studies, internships or research), AMI and Erasmus+, Aide for international mobility of the doctoral college and mobility scholarships for graduate programs. (Any student eligible for one of these programmes is not eligible for the Mobiliex scholarship)

- For young researchers, if the laboratory co-finances mobility, the Mobilex grant cannot finance the same expenses.

- Never benefited from moblilex

- Notification and classification of components and doctoral schools (Any file not classified will not be reviewed and will be immediately rejected)

- For incoming mobility: students and doctoral students in a situation of mobility (students and doctoral students already present in France are not eligible). the programme does not finance incoming mobility for young researchers.

• Whether or not the doctoral student receives funding

• Sincerity and reasonableness of the budget

INCOMING MOBILITIES

ATTENTION: MOBLILEX is a mobility grant that cannot be used as thesis funding.

- Final MOBLILEX's table of classification is carried out and reported by the Doctoral Schools.

- Priority is given to mobility within the framework of existing and structuring cooperation (bilateral agreement, IRL, research cooperation agreement, etc.)

- Priority mobility areas: 3i Network (KU Leuven/Kent/Ghent), European NeurotechEU Alliance, InclusU network

- For incoming doctoral mobilities, the MOBLILEX scholarship will be given as a priority to doctoral students in joint supervision (finalized agreement or agreement under process)

- Taking into account the year of registration in thesis (Moblilex scholarship can only be granted to doctoral students enrolled in 1st, 2nd and 3rd year, or on derogation and reasoned opinion for the 4th year)

OUTGOING MOBILITIES

WARNING: Any mobility of less than 3 months, is not eligible and may be the subject of an application to scholarship from the Doctoral College.

- Final MOBLILEX ranking carried out and reported by the Doctoral Schools

- Priority given to mobility within the framework of existing and structuring cooperation (bilateral agreement, IRL, research cooperation agreement, etc.)

- Priority mobility areas: 3i network (KU Leuven/Kent/Ghent), European NeurotechEU Alliance, InclusU network

- Taking into account the year of registration in thesis (are funded only doctoral students enrolled in 1st, 2nd and 3rd year, or on derogation and reasoned opinion for the 4th year)

4. SPECIFIC CRITERIA APPLIED TO OUTGOING STUDENT MOBILITY FOR YOUNG RESEARCHERS AND POST-DOCS

In addition, the reasoned opinion justifying the classification of the file by the component must take into account in particular:

• The scientific quality of the on-site work programme, its organisation (schedule and stages) and the relevance of mobility in relation to the young researcher's subject of study.

•The existence of structuring cooperation for the work and/or for the research unit and/or for the university where the mobility is envisaged. E.g. formal or informal partnerships, ongoing or future, real or potential (IRL; other research programmes)

• The fact that the young researcher benefits from possible co-financing (laboratory, etc.)

• Sincerity and reasonableness of the budget

OUTGOING MOBILITIES :

ATTENTION: mobility of less than 1 continuous month is not eligible and the MOBLILEX scholarship does not finance participation in congresses or symposia.
